# Road Safety Week 2022



## ROAD SAFETY WEEK 14-20 November 2022

### WHEN IN A VEHICLE:



- Watch your speed. In some road conditions including fog, rain and traffic flow, driving or riding at the **speed limit could be too fast**
- The automatic lights feature does not have any rear marker lights. During poor visibility conditions, turn on your manual lights to activate your taillights.
- If you feel **fatigued**, find a safe place to stop and have a coffee and or nap
- **Do not use mobile phone while driving**
- Ensure to carry out regular **vehicle checks** so vehicle is road safe

### AS A PEDESTRIAN:



- Wear **fluorescent** clothing during the day and **reflective** clothing at night
- Walk in **well lit** areas as much as possible
- Use **pedestrian crossings** where possible
- If there is a **footpath**, use it. If there is no footpath, walk/ run/ jog on the right hand side of the road, facing oncoming traffic and keep as close as possible to the side of the road
- Never cross a road on a **bend**

### WORKING ON ROADS:



- Always wear **hi-vis**
- Ensure road signs & chevrons are in place & **visible** to road users
- Ensure **permits** are in place
- Ensure a **traffic management plan** is in place and all workers familiar with it
- **Remain calm** in the event of road rage incidents
- **Report any and all incidents** to authorities

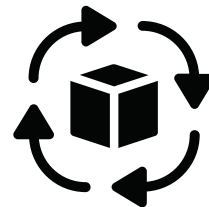
